## AFFIDAVIT FOR ARREST WARRANT

BEFORE ME, John D. (Jalluzzo, a Judge of the Eighteenth Judicial Circuit in and for Seminole County, Florida, personally appeared Police Officer/Detective William Powell of the Oviedo Police Department, Affiant herein, who first being duly sworn by me, deposes and requests that an arrest warrant be issued for:

for one count of: Homicide - First Degree Murder, Premeditated, contrary to Florida Statute 782.04 (1)(a)(1).

Your Affiant states that the facts establishing probable cause for the issuance of a warrant are as follows:

Your Affiant, Detective William Powell, is a duly sworn and certified Law Enforcement Officer in the State of Florida and has been employed as a sworn Police Officer for the Oviedo Police Department since August of 2010. Your Affiant is a certified Law Enforcement Officer by the State of Florida and pursuant to Section 943.14(1)(2) Florida State Statute and Sections 11b-7, Florida Administrative Code relating to the Standards and Training. Your

Affiant attended Seminole State College Law Enforcement Academy for basic certification as an officer. During that time, the basics of criminal investigations were taught. Your Affiant has completed Florida Police standards required by the State of Florida. Your Affiant is currently assigned to the Criminal Investigation Section of the Oviedo Police Department and has completed numerous investigations, which have led to the arrest of subjects in crimes in general. Your Affiant has attended numerous FDLE approved courses to include Interviews and Interrogations and Advanced Report Writing. Your Affiant has also taken multiple college level classes in reference to Criminal Justice and holds a bachelor's degree from the University of Central Florida.

On Monday, January 27, 2014, your Affiant was advised of the following information concerning the chain of events in this investigation:

Prasad Chittaluru received an email from his sister, Sujatha Guduru, which had a date and time stamp of January 27, 2014 at approximately 0545 hours.

Chittaluru responded to the home shared by his sister, Sujatha Guduru and Guduru's daughter, Chetana Guduru, located at 560 Farmingham Court Oviedo, Seminole County, Florida, and found his niece, Chetana Guduru on a bed in the master bedroom with an apparent gunshot wound to her head, and his sister, Sujatha Guduru, on the floor next to the bed in the master bedroom with an apparent gunshot wound to her chest. Prasad Chittaluru called 911.

First responding Officers responded to 560 Farmingham Court at approximately 0723 hours and entered the residence. Responding Officers observed Chetana lying on the bed in the master bedroom (face up), head towards the headboard, with a gunshot wound to the head/face and a significant amount of blood in the head/facial area. Responding officers observed Sujatha lying on the floor next to the bed in the master bedroom (face up) with what appeared to be a gunshot wound to the chest. Responding officers observed Prasad standing next to the bed, on the telephone, receiving instructions from Oviedo Police Department dispatch for CPR. Responding officers observed a grey revolver handgun on a table near the dining area; it was later determined that Prasad initially located the handgun on the floor next to Sujatha and relocated the weapon to the dining room table prior to the responding officers arrival.

The following items were immediately visible by the Officers: a pillow on the bed in the master bedroom with blood, bedding on the bed in the master bedroom with blood, one juvenile victim, Chetana Guduru, with a gunshot wound to the head/face lying on the bed in the master bedroom, one adult victim lying on the floor next to the bed in the master bedroom with a gunshot wound to her chest, a grey revolver resting on the dining room table with three spent/discharged casings in the cylinder. Responding Officers also observed the front door to the residence was locked, and the residence was occupied at the time of their response.

The Oviedo Fire Department responded to the residence and observed vital signs in both subjects. The Oviedo Fire Department transported Sujatha Guduru to Orlando Regional Medical Center (ORMC) in Orlando and transported Chetana Guduru to the Oviedo Emergency Room for stabilization, and once stabilized, Chetana Guduru was transported to ORMC in Orlando. The Oviedo Fire Department personnel described the injury to Sujatha Guduru as a gunshot wound to the chest. The Oviedo Fire Department personnel described

the injury to Chetana Guduru as a gunshot wound to the head. There were no other injuries immediately visible. Your affiant was informed that Chetana Guduru died as a result of her injuries.

Your affiant observed a blood pool on the floor next to the bed in the master bedroom.

Your affiant observed a blood pool on the bedding and pillow on the bed in the master bedroom.

Your affiant observed a blood pool on the tile floor adjacent to the kitchen.

Your affiant was informed by initial responding Officers that Sujatha Guduru sent an email to family members (which your affiant has observed)

Your affiant observed a picture of this email taken from Prasad Chittaluru's cell phone. It is not known at this time if Sujatha Guduru sent this email from a cell phone or a computer. Multiple computers were seen within the home by initial responding officers, and Prasad Chittaluru told officers that he knows his sister, Sujatha Guduru, to have a smart phone capable of sending and receiving e-mails. Your affiant observed a Dell laptop on the floor of the master bedroom which had visible on the screen the "signout" page for the live.com website. Your affiant knows through his experience that live.com is a website operated by Microsoft by which users can access "Hotmail" accounts. Your affiant knows that the email referenced in this affidavit was sent from a Hotmail account.

On January 27, 2014, Detective Daniel Mattingly and Lieutenant Adam Egert, both of the Oviedo Police Department, responded to the Orlando Regional Medical Center (ORMC) in Orlando, Florida to interview Sujatha Guduru. Detective Mattingly informed your affiant that he advised Sujatha Guduru of her Miranda rights by reading from a pre-printed, department issued Miranda Warnings card, which she understood. Detective Mattingly informed your affiant that Sujatha Guduru agreed to answer questions

Detective Mattingly informed your affiant that Sujatha Guduru stated she purchased the firearm used in this crime on January 21, 2014 and picked it up from the gun dealer on Saturday, January 25, 2014. It should be noted that evidence located at the crime scene, to wit a receipt for the purchase of the firearm, corroborates this information. It should also be noted that the discovery of the receipt was not relayed to Sujatha Guduru. Detective Mattingly informed your affiant that Sujatha Guduru stated she awoke on January 27, 2014 at approximately 0500 hours. Detective Mattingly informed your affiant that Sujatha Guduru stated at approximately 0545 hours, Sujatha Guduru emailed her brother, Prasad Chittaluru,

informed your affiant that Sujatha Guduru stated she waited until she believed her daughter had died and then shot herself in the chest in an attempt to commit suicide.

It is requested that Sujatha Guduru, identified hereinabove, be charged with one count of Homicide – First Degree Murder, Premeditated, which is a capital felony, contrary to FSS 782.04 (1)(a)(1). This felony was committed on January 27, 2014 in the City of Oviedo, Seminole County, Florida.

WHEREFORE, Based on the fact that Sujatha Guduru did knowingly and intentionally, and with premeditation cause the death of Chetana Guduru, Sujatha Guduru's juvenile daughter, your Affiant prays that a warrant be issued commanding all Sheriffs or any of their duly authorized deputies to arrest Sujatha Guduru for the above listed charge and bring her before the Court so that she may be dealt with according to law.
