The revised CR is attached. Effort sheet and the FP CR is also attached.

Notes:

1. Changed start dates from 11th Oct to 9th Oct as everyone appears on bench for 2 days.
2. Considered 2 days per week for sujit.
3. Projected T&E calculation is as under:
 - a. Previous month deficit 6619 + 1700X3 (3 weeks projection for Jay) = 11719
4. Travel kept as-is at 5500. Not sure for whom it will be used.

5. FP CR for Vishal is only till 15th Oct as he completes 45 days on Monday 18th Oct. He on B-1 Visa It will good to have him travel back on 15th and continue on T&M at offshore.
